**Delhi Assembly Elections 2008**  
**Winning Candidates (MLAs) Criminal and Financial Record**  
**Delhi Election Watch (DEW) 2008: Date 12 Dec, 2008**

**General:** In 2008 Delhi Assembly elections, a total of 863 candidates contested for 69 seats, representing 69 parties. Out of 69 parties, only 4 parties have been successful in sending one or more MLAs into the Vidhan Sabha. 65 parties that contested elections did not win a single seat.

DEW has looked at affidavits of all winning candidates (MLAs) coming into the newly formed Vidhan Sabha. 4 affidavits available on Delhi CEO's website are not scanned properly and unclear details in them have not been taken into account. We have requested the Electoral office to have these affidavits re-scanned and be put on the website, so that general public can access this information.

**MLAs with criminal background:**

There are 27 newly elected MLAs with criminal cases pending against them. The party wise distribution of these MLAs is:

As compared to 2003, the no of MLAs with criminal records has gone up from 24 to 27. In the 2003-2008 Vidhan Sabha, BJP had 11 and INC had 12 MLAs with criminal records.

There are 6 MLAs with serious charges of crimes against them, including murder, attempt to murder, kidnapping, and assault to women with intent to outrage her modesty. The list of all these candidates is attached at the end.

**Financial Background:**

All the MLAs in the current Vidhan Sabha are either Lakhpatis or Crorepatis. There are a total of 46 crorepatis. Congress has 24 crorepatis, BJP has 19 crorepatis, BSP has 2 crorepatis and 1 IND.

As the table below shows, the chances of winning are higher for candidates with more assets. At one extreme, 0% of candidates with declared assets of Rs 5 Lakhs or less won. At the other, 31% of candidates with declared assets of Rs 5 Cr or more won.

The average asset of winners is 2.8 Crores. The average asset of a congress MLA is 2.7 Crore and that of BJP is 2.86 Cr. The MLA with the lowest Asset value is just above 5 Lakhs followed by another with 8.34 Lakhs.

3 MLAs have not declared their PAN card no. This includes 1 MLA who has declared his assets to be more than 1 Cr. All MLAs who have not declared their PAN numbers are listed at the back.

*Agriculture Land Ownership:*

29 MLAs have declared that they own agriculture land. 11 of them own agriculture land worth more than 1 Crore.

*Jewellery:*

25 MLAs have declared that they own jewellery worth more than 10 Lakhs, 5 of them have declared their jewellery to be more than 30 Lakhs. The list of these MLAs is attached at the back.

*Vehicle Ownership:*

12 MLAs with assets worth more than a crore have declared that they own no vehicle.

**Women MLAs:**

There are only 3 women MLAs in the new Vidhan Sabha. All three women MLAs are from congress, which had fielded 8 women candidates. There are no women MLAs from BJP which had fielded 4 women candidates (or any other party). In 2003, there were merely 7 women MLAs, which has further reduced. The % of women MLAs in Delhi is around 4%.

**Representation of SC and ST**

There are a total of 12 SC and 57 GEN MLAs into the newly elected 2008 Vidhan Sabha.

**About DEW**

Delhi Election Watch (DEW) is part of a nationwide campaign called National Election Watch (NEW) working on improving democracy and governance in India. It is a citizen led non-politically aligned, non-partisan effort. This time several NGOs, civil society and peoples' organizations from Delhi are participating in this effort.
